MY legal Name is Robert West and
I'm an inmate in the United States of America
and of the State of Illinois and presently
I am incarcerated in the Illinois Department
of Corrections ("IDOC") under their alphabeti-
cal Numerical identification system as B-03903.
I was sentenced to an aggregate 60 Years
@ 50% For Armed Robberies and I have been
in continuous incarceration since August 19, 1991,
and there was no violence in those cases or
MY background.
I subsist Within a culture of abuse and
intimidation perpetrated by corrections employees
against Noncombatant inmates, and the more
they abuse us, the more we become lickspittle
and ingratiating towards them.
As a person held in imprisonment now near-
ing a quarter of a century, the reason for my
Writing this Missive is to reveal facts, With
aim to Mention the injuries and ruins to peo-
ple caused by the Macrocosmic indifferences of
society, as transferred into the Microcosmic
penal culture of corrections.
The degree of civilization in a society
can be judged by entering the prisons." (Fyodor
Dostoyevsky).
From MY conversations with Fellow inmates,

and also of MY own personal experiences, during 28 the entire period of imprisonment, IDOC inmates 29 has been and is presently subjected to a con-30 tinuing course of arbitrary or oppressive treat-31 Ment, as the result of Mismanagement on the 32 part of State prison Managers that is so gross, 33 it must be considered to be Willful. 34 The unwritten policy and practice of the 35 daily maltreatment of Illinois inmates stems from 36 the infamous "Richard Speck Tapes," aired in the 37 Year of 1996, by CBS television station and 38 Chicago's Channel 2 news reporter, Bill Curtis, Who 39 exposed the irrefutable reality of an IDOC 40 penitentiary, where prison Managers at Stateville 41 Correctional Center were caught compromising con-42 trol of the inmates by allowing for an environ-43 Ment for homosexuality, and a place for illicit 44 drug parties, where Male adult inmates filmed 45 themselves creating gay porn and apparently 46 snorting narcotics while housed inside of a 47 Maximum security prison. 48 Corrections employees are given enormous power, 49 and often they're so Myopic with that power, to 50 they have lost ability to see that Many of them 51 has No idea of What to do With it, other than 52 to use their authority arbitrarily or as an in-53 strument of oppression. They are legalized 54

55	bullies who expects for inmates to respect
56	the so-called peace officers badges when they
57	themselves Won't respect it. Nefarious faust-
58	ians whom serves no penological purposes other
59	than to Further psychologically damage people by:
60	a) instilling Within pusillanimous inmates pro-
61	Found pessimism and deeper despondency to
62	discourage protest j b) Manufactoring bitter
63	sociopaths consumed by irreparable animosities j
64	c) Metamorphosing even themselves into Narcis-
65	sism and diabolical sadists j and, d) et cetera
66	etc.
67	While doing time inmates perfect their
68	predictions of officers behavior. They tell
69	only what is acceptable and they conceal their
70	true beliefs, impressions and ideas behind
71	Masks. It is better in a survival sense, to
72	tell officers What they want to hear and con-
73	tinue to go unharmed than to tell unpleasant
74	facts and be falsely accused of Misconduct or
75	held by mechanical restraints, beaten, tranquilized
76	by psychotropic drugs, placed in 24-hour days
77	confinement, or lose good time credits.
78	Just illustrating one example, IDOC Rule,
79	§ 504A, Offense 304 Insolence, it's defined, in
80	part, in quote, as "talking, gesturing, or
81	other behavior that, annoys, La corrections

82	employées. End quote. Maximum penalties
83	are one Month segregation and one Month
84	good time revocation.
85	Solely speaking For Myself, I was psychologi-
86	cally raped on May 3, 2014, by the IDOC' Special
87	Operations Response Team ("SORT") tactical unit
88	officers with impunity from prison officials,
89	Who gave strangers voyeuristic viewing of
90	parts to MY body that I MYself can't see -
91	- (i.e. anal sphincter).
92	In addition to that, I'm also emotionally
93	damaged as a result of MY having been emas-
94	culated by SORT officers.
95	Moreover, responsible for MY Mental decom-
96	pensation is the fact that state legislators
97	gave to the IDOC the army, the armory, and
98	carte blanche authority, cause there's no sta-
99	tutory sanction to be levied against the IDOC
_00	For the unnecessarily and wantonly Manhandling
01	of inmates for the Malicious purpose of inflic-

.06	officers has unlimited and unwelcomed access
07	to inmates bodies. And, by sword of Da-
.08	Mocles an adult male inmate can be ordered

109 to disrobe unto nitty-gritty nakedness, and under 110 duress must capitulate to orifice inspection, to 111 include being compelled to show his anal sphine -112 ter to the officer. 113 ON May 3, 2014, an IDOC unprovoked lock-114 down operation had been in effect. While I 115 was in MY assigned cell obeying the IDOC rules, 116 an army of SORT tactical officers stormed the 117 housing unit and an officer, in full riot gear 118 and having a bellicose disposition, ordered me to 119 disrobe. The compulsory nudity was exercised 120 in the Manner of a strip show willy-nilly. 121 BY sword of Damocles, the officer forced 122 Me to open MY mouth and stick out MY tonque, raise 123 MY top lip and lower MY bottom lip, comb through 124 MY hair With MY Fingers, turn MY head right - to-125 left for him to look into MY ears cavity, raise 126 MY right & left foot and wiggle toes, lift MY 127 scrotum, hold MY penis by the shaft and peel 128 back the Foreskin, turn around 180° with MY 129 bare buttock facing him and bend forward at the 130 Waist Without bending the Knees, grab MY rec-131 tum with MY hands, separate MY butt-cheeks 132 and hold it in that wideopen posture until he 133 gave permission for me to release the grip. 134 The officer then gave to me to wear only 135 an undershort, pant, shirt, socks and boots,

and thereafter I was handcuffed and compelled
to stand soundless and Motionless with MY
Nose and eyebrows pressed to the wall's paint
as officers stood behind MY back fidgeting
With billyclub sticks. As inmates had turned
in a cursory look behind them at the SORT's
uncalled-for activities, they was Yelled a Forceful
Warning to face the wall and not again move!
720 ILCS 5/12-1.
After standing still for Many Minutes as a
sphinx and thereafter the degradation Meted
Finally appeased the officers' fancies, I then
was ordered to walk in tandem step, in tem-
perature below 60°, between two rows of
officers down a long and narrow corridor con-
Nected to the dining room.
When I entered into the dining area I
was held there for several hours in handcuff
and the absence of heat or warmth. An
elderly and infirmed inmate, to, wit: Albert
Sullivan, asked for his coat or a blanket to
cover the loss of his body heat and the
officers devied his request via their Mockeries.
Upon MY return to the cell it was clear-
LY obvious MY clothing, books, papers, and pur-
chased commissary items were strewn all over
the place as though the officer had tossed

163	and Frisbee-Flinged MY personal property.
164	everywhere.
165	Mental cruelty is defined under Illinois
166	Law as — "a course of unprovoked offen-
167	sive conduct toward [a person] which causes
168	embarrassment, humiliation and anguish so as
169	to render the [person's] life Miserable and UN-
170	endurable, and which actually affects the
171	[person's] physical or Mental health." Christian

174	I was in such a distress by staff
175	conduct to a degree I couldn't even recognize
176	Whether or Not the SORT officer had a name
177	tag identification visible. In addition to that,
178	the officer's name wasn't legible on the copy
179	of the shakedown record gave to Me.
180	Furthermore, the grisly stripping exhibition
181	and supererogatory abuses described, exasperated
182	MY DYsthymic Disorder and the images has con-
183	tinued to plague me with intermittent depressions
184	during MY confinement in the IDOC.
185	AN IDOC Offender's Grievance report was
186	Filed June 21, 2014, titled: "Staff conduct." I
187	
188	had asked therin the complaint for IDOC staff
189	Members to "cease oppressive treatment of in-
	Mates and desist from tampering with the

emotions of Voiceless, helpless, powerless, and 190 defenseless human beings." The grievance was 191 192 exhausted at the Local level on June 23, 2014. I appealed to the IDOC Director in July of 193 194 It was denied by the IDOC Administra-195 tive Review Board cause their office determined 196 that there were "No violation of [Departmental 197 Rules 1 120 or 501c. "And, on January 7, 2015, 198 the Director concurred with the Board. 199 The Federal court have ruled that the 200 constitution provides no protection to inmates 201 Falsely accused of Misconduct. The court held 202 it doesn't violate the 8th Amendment's ban on 203 cruel and unusual punishment to punish inmates For absolutely "No reason at all." Leslie 204 V. Doyle, 896 F. Supp. 771 at 774 (N.D. Ill. 205 206 The SORT officers at other IDOC prisons 207 208 were more egregious. At other correctional 209 centers the officers grabbed the back of each 210 inmate's head and slammed it violently into the 211 back of the inmate ahead of him in line. The 212 officers ordered the inmates to stand in such 213 a way that one man's genitals were in direct 214 contact with the buttocks of the Man ahead of 215 him in line - referred to by the SORT officers as "Nuts to Butts." 216

The officers forced the inmate to straighten his leg while Keeping his back bent. over at a 90-degree angle onto the inmate in 3 Front of him. This hand the effect of forcing 4 the Men to place their genitals directly against 5 the buttocks of the Men in Front of them. The 6 officers then ordered the inmates to March in that formation. Every time that an inmate's 8 head came off of the back of the inmate in Front of him, the SORT officers responded with 10 Violence. 11 Although I'm upset about procrustean officers 12 ogling MY private orifice, I now feel Luckjer to 13 have been abused at Dixon prison than to been 14 at other IDOC prisons having had a possibly un-Washed penis touching one's posterior. 16 verify the accuracy of the claims herein, see 17 the civil case # 3:15-cv-00309 of Demetrius 18 Ross V. Plus, deductions 42 are Made for all legal photocopies and postage 43 costs. 44 I've done an introspection and have under-45 gone an exorcism. I am the beneficial of a 46 soteriological experience and I now eschew all 47 wrong doing prohibited by the KJV-bible.
