As I entered Polk youth institution my heapt Was still broken as I ponderection the facts) that I had sinned against God, against bumanity, and thirdly I was engaged to be married to the woman - -----

- of my dreams (Jamantha L. Torres) but I knew within my heapt she would eventually depart from me due to my present situation. Nost men who came to prison like & did were in the Streets caught up in the game. So when They come to prison for a king period of years, they lose the game. Huwever When I came to prison, I did not lose The game (I never had it), but I lost love and the pain from losing love is tak greater then the pain of losing the game (streets). Two things I have tound to be true: Éveryone needs love, and Éveryone needs to love somebudy! Growing up as a man I was never under any authority my corandinother raised me and as

- a christian Women should, she brought me up in the way's of the church, however the band of authority and discipline never gripped spe. When Farrived at POIK youth institution the inmates housed there were very Peckless and indifferent towards eachother. The level of Violence was unspeakable and never ceased. I knew That this type of behavior amongst the inmates there Was common, however the correctional afficens displayed a type of attitude and aggression that although this was my first time in prison, I knew that how they treated the inmates there Was not in accordance with policy pertaining to a correctional officers conduct.

E can remember at night un our beds when the lights were turned off their and be no talking, yet you always had one of two inmates That rebelled. Su a currectional Sgt. entered the dorm, with about eight other correctional officers, made all of us (inmates) get out of bed, pack all of au property into a mattress sover and stand outside in the cold holding out property for topty-tive minutes to an hour. Not to mention that some inmates unly had butens and I-shirts un as they stood out in the cold as punishment. On Several occasionis & Witnessed correctional officers physically assault inmates to the point of blood sheel.

An every situation & Witnessed, no correctional officer had been Justified in they're actions toward assaulting an inmate. The right authority when exercised within a prison places things and people in order, While gielding the Fruit of a moderate (balanced) enviorment that henchions within the policies and procedupes established. The wrong authopity when exercised within a prison allows inmakes and correctional officiens to conduct themselves in a Way that is contrary to prison policies and procedures, while yielding the fruit of a immoderate, chaotic, and un controlled environment. When administrative officers abuse they're authority it can contaminate -

- a entire prison from the office of the superintendent, to medical statt? to the chaptaincy, to the units and dopms. Eighty-five percent of Administrative officers in north Capolina's prison system use authopity to be vindictive towards inmates they personally dislike due to the crime that an inmate has committed and for they consider inmates to be less than human, to the measures weed by these type of administrative officials are inhumane. A prison located on the Western region of North Carolina in Spruce pine, north Carolina Called, Mountain View Correctional is most notorious for being inhumane towards inmates.

F can recall Dighty-eight percent of the prison staff being white perkaining to pace) and though hatted without partiality was shown to most of the inmate population, their was no besitation towards the inmates that were not white. F can remember the yard (recreation time) opening up, and on most prison's the yard doops remain open so that inmates May exit the yard when they're had enough recreation time. At Mountain view Currectional inmates that enter the yard must stay out on the yard for an entire hour then they may return to the clorm. The only problem is that alut of inmates had medical conditions some had issues with they're Kidney's -

- or prostate making it impossible for some inmates to hold the flow of upine or control bower provements So the same inmates Would defecate on themselves. When it was brought to the attention of prison staff and administration, the same inmates were given an intraction, thrown in segregation (isulated cell) and beaten. the Witnessed other inmates pass out (faint) and have seizures because they had to stay out un the yand for an hour, and did not have access to they're medication. These inmates were also thriwn in to Segregation, beaten, and given an intraction. Please note that I don't have a problem With pules or authority my prison record -

- confirms that, and I must say that alot of the rules, policies and procedures instituted by surve prisons, in north Capolina are not being used as preventative methods aptimisticly, but are intented to keep the spirit (influence) of confusion, harred, and violence, between inmates and competional officers alive. It is my belief that prison is never suppose to be a Joyful experience, their should be no special treatment for any inmate, however neither should an inmate be Willtuly, Malicious mistreated cender any prison authority, in any manner monso Vindictively. The prison term given to an inmate by the Judicial System is sufficient. Any administrative official currectional officer)-

- Who has some personal interest towards any inmate whether good or bad for any reason should not be allowed or employeed within north capolina's prison System. Acruss nurth Carolina their are Many prison's That are guilty of ablesing inmates through allthonity, tie Only named two that I experienced as perfect examples of Administrative officials, and how they use their authopity, in the Wrong mannet. Out of the eight Prisons in north carolina where I have served my prison term all of them tailed in exercising authority. Make no mistake tam not saying that all prisons Should be flawless in how they treat inmates of without error as pertaining -

- To authority, however the standard for exercising authority should be high and steps taken to secure every ettopt to meet that standard. This is essentiality seeing that people's lives are at statte, and (though inmakes) their lives still matter to God, and to the huesehold they came from, when I came to prison in the year 2000, the administrative officials (correctional officers) had quality of character and they fulfilled that which a correctional officers Job requires nothing more or nothing less, they were neutral! At that time the nurth capolina Prisup system Was Called the Department of Corrections. However between and for Jecember 2011, -

- and January 1, 2012. the North capolina prison system was no longer called the department of currections. The name was changed to the department of public sately. It is my opinion that arrived This time the north capolina prison system became a business that made primary two things: Cuppency and keeping the public safe. Yes The prison system has always been about money, however it's purpose used to be the Republicitation (creating the right conditions for the inmakes to change) process as an inmate cappied out his prison term. However now present 2016) north Capolina's prison is all about incorporating means for finaca (money) -

- While making sure most of the inmates either spend the rest of they're lives in prison or die in prison. Er an example: now presently (2016) when an inmate recieves an infraction, he dosen't Just lose privelages like. the phone, visitation of canteen, the administration also takes tendollars from the inmate. This happend when the north carolina Prison system changed from O.O.C. to D.P.S. The cost to go to medical became greater, the price of everything became higher, however the appount of cents an inmate makes trip Jub assignments did not change. So what dues an inmate do, be gets un the phone and asks his tamily to send -

- bion money, which is what the prison system Wants. The inmate who dues not have mural support trum tamily and triends suffers greatly. Fan tamiliat. their was a time during my prison Yerro That all the support I had morally was from my grandmother, however through the years my beavenly tather has blessed me with a real big tamily Who loves me and supports me in everyway The amount of inmales that the Witnessed die throughout my prison term is heartbreaking.
