Iwo things A have found to be true: Everyone needs love and Everyone needs to love somebody! Growing up as a man it was never under any authority ing ceriandinother paired me and as

- a christian women should, the brought me up in the way's of the church, however the band of aultonity and discipline never grippedree. When A arrived af Pork youth institution the inmates housed there were very reckless and indifferent tu wards eachuther. The level of violence was unspeaisable and never ceased. It knew that this type of Behavior amongst the inmates there was common, however the cunpectional officers displayed a type of attitude and aggression that although this was. my First time in prison. I knew that how they treated the inmates there Was nut in accundance with policy pertaining to a correctional officers conduct.

A can remember al night un our beds when the lights were turned of their could be no larking. yet you always had one or two inmates. that rebelled. So a curnectional sgt. entered the dorm, with about eight other correctional officers. made all of hs (inmates) get out of bed. pack all of our property into a mattress cover and stand outside in the cold holding our property for fonty-five minutes yo an hour. Not to mention that some inmates. only had butens and l-shipts on as they stood out in the cold as punishment. On several occasions \& witnersect correctional officers physically assault inmates to the point of bloodshed.
theveny situation it witnessed, no correctional officer had been Justified in they're actions Howard assaulting an inmate. The right authority when exercised within a prison places things and people in under, while yielding the Fruit of a moderate (balanced) enviormentent that functions within the policies and procedures established. The wrong authority when etencived within a Prison allows inmates and correctional officers to conduct themselves in a way that is contrany to prison policies. and procedures, white yielding the fruit of a immoderate, chaotic, and uncontrolled environment. When administrative offices abuse they're authonily it can contaminate -

- a entire prison from the office the superintendent, to medical staff, to the chaplaincy, to the units and dorms. Eighty-five percent of Administrative officers in northcanolinai prison system use authority to be vindictive towando inmates they personally dislike due to the crime that an inmate has cumnitted andlor they consider inmates to be leos than human, so the measures cooed by there type of administrative officials are inhumane. A privun located on the western negion of North carolina in spruce pine north carolina called. Mountain view correctional is most notorious for being inhumane towards inmates.

of the prion staff being white pertaining to pace) and though hatred without partiality $\sqrt{\text { as shown to most of the }}$ inmate population. their was no hesitation towards the inmates that were not write. It can remember the yard (recreation time) opening up, and on most prison's the yard sloops remain open so that inmates may exit the yard when theyive had enough recreation time. AY Mountain view correctional inmates that enter the yard must stay out on the yard for an entire hour then they may retene to the corm. The only problem is that abut of inmates had medical conditions sone had issues with they're Kidney's -

- ur prostate mating it impossible for some inmates to hold the Flow of urine or control bowel movements so the some inmates would defecate on themselves. When it was brought to the attention of privun staff and administration, the same inmates were given an infraction, thrown in segregation (isulated cell) and beaten. Hie witnessed other inmates pass out (taint) and have seizures because they had to slay out on the yand for an hour, and did not have access to they'r medication. These inmates were also thrown in to segregation beaten and given an infraction. Please note that I dunt have a problem With rules or aulturity my prison record -
- confimpor that and must say that aloft of the ruler, policies and procedures instituted by combe prisons. in nurthcanolina ane not being used as preventative methods optimisticly. but are intented to lues the spirit (influence) of contusion, hatred, and violence, between inmates and cometional offices alive.' It is my belie t that prison is never suppose to be a Joyful experience, their should be no special Areatpont for any inmate, however neither should an inmate be wilfully, malicious mistreated under any prisun authority. in any manner mono vindictively. The prion term zen to an inmate by The judicial system is sufficient. Any administrative official (currechunal officer)-
- who has some personal interest tuwands any inmate whether good ur bad for any reason should not be allowed or employed within nonthcapolinais prison system. Across nunth carolina their ane many prisons that ane guilty of
ableving inmates throw eh authority. Lie only named two that it experienced as perfect elyamples of Administrative officials and how they we their authority, in the wrong manner. out ut the eight Prions in north carolina where 4 have served my prison term all of them failed in exercising authonty. Nark e no mistake Lam not saying that all prisons should be flawless in how they treat inmates or withoul error as pertaining -
— Mo authority. however the standard for exercising authority should be high and steps larsen to secure event effort to meet that standard. This is essentiality seeing that people's lives ane at stake, and (though inmate s.) their lives still matter tu aud, and to the nuwehold they came from. When to came to prison in the year 2000. The administrative officials (convectional officers had quality of character and they fulfilled that which a correctional officers job requires nothing more or nutting less, they were neutral! At that time the nunth carolina Prison system was Called the Department of Corrections. However between und/ur December 2011.-
$\rightarrow$ and January 1,2012. the
Worth carolina prison system was no longer called the depantipent of cunpections. the name was changed to the depantiment of public ovately. It is my opinion that around this time the north carolina prison system became a business that made primary tyro things: cuppency and keeping the public vale. yer the prison system has always been about money, however it's purpose used to be the rehabilitation (creating the right conditions for the inmates to change) process as an inmate carried out his prison tenn. However now present y (2016) month Carolina's prison is all about incurpurating means for finaica (money) -
- while making cure most of the inmates either spend the nest of they're liver in prison or die in prison. For an example: nus presently (2016) when an inmate reciever an infraction, he closen't Just lose privelages like e the phone, vivitaliou or canteen, the administration also Lakes tendullans from the inmate. This happened when the north carolina prison system changed from O.O.C to APIs. The cost tu go to medical became greater. the price of every thing became higher, however the arpount of cents an inmate makes from vol assignments did nut change. So what clues an inmate do, he gets on the phone and asters his family to vend -
- him money, which is what the prison system wants. The inmate who dues not have mural ruppunt from fainily and friends suffers greatly. Lt am familiar. their was a tine curing my prison tern that all the ruppont it had morally was from my gnandinother. however through the years my heavenly father has blessed me with a peal big family Who loves me and crepponts be in everyway. The amount of inmates thu 4 tire Witnessed die throughout my privontern is neat breaking. the minonty die from natural causes, the majority die from Administrative officials and the authority mos used!
