THE SAME NUMBERS AGAIN. ONLY WHEN YOU REACHED HER AND HAD HER CHECK THE NUMBERS, THEY HAD BEEN ALREADY UPLOADED TO SOMEONE ELSE'S CARD. IF IT WASN'T YOU OR YOUR GIRLFRIEND, THAT WOULD LEAVE ONLY THE PRISON GUARD. THE MERE MENTION OF A PRISON GUARD "LARCENY", PRISONERS GET A (A-18) MISCONDUCT INFRACTION. A (A-18) BASICALLY IS SAYING YOU ARE LAYING ON THE PRISON GUARD. NOW NOT ONLY HAVE YOU LOST MONEY OFF THE "GREEN DOT REFILL MONEY PACK", BUT YOU ALSO LOSE \$10.00 IN ADMINISTRATION FEES FOR THE (A-18) WHICH WILL BE ALMOST IMPOSSIBLE TO BEAT. ~~A LAST, LOSE \$~~
