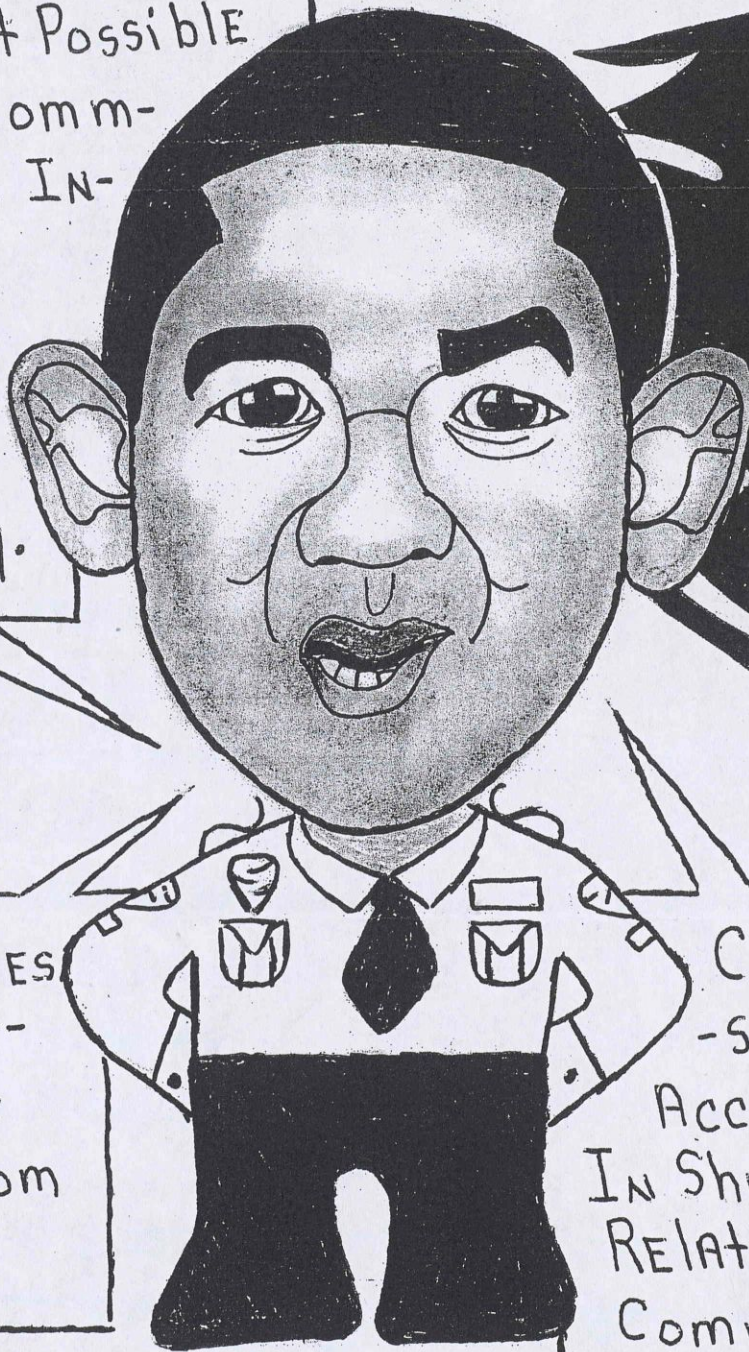

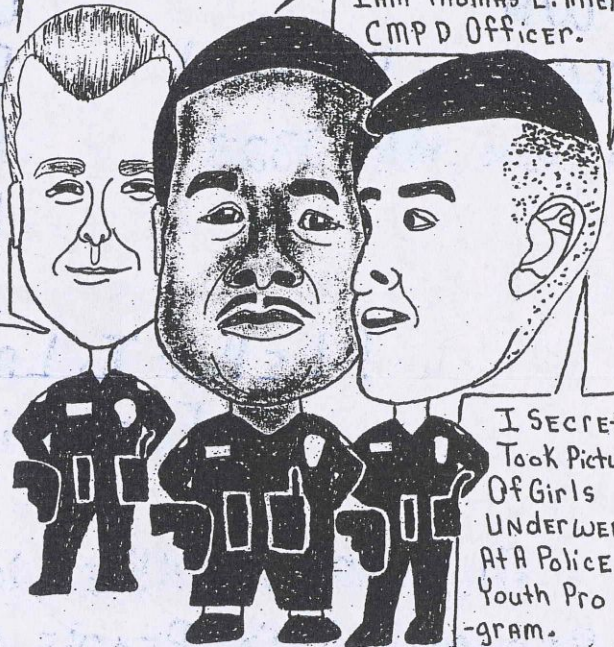

I NEVER FACED ANY CRIMINAL CHARGES!!!

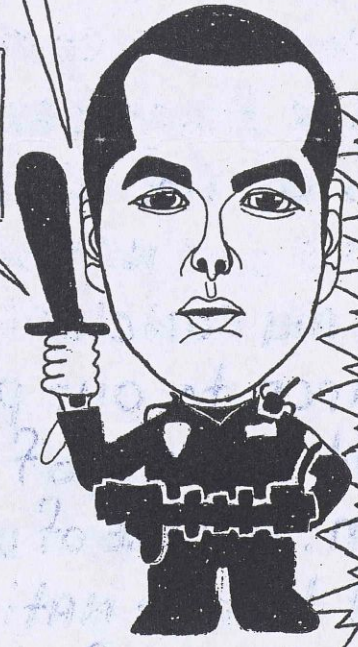


My fellow officers never probed into why there was no audio or video recording or if there was any other officer at the scene.

- At least 70 departments scattered from Connecticut to California arrest black people at a rate 10 times higher than people who are not black.
- Nationwide blacks are stopped, searched, arrested, and imprisoned at rates higher than people of other races.
- Only 173 of the 3,538 police departments USA today examined arrested black people at a rate equal to or lower than other racial groups.
- From 1970 to 1995, the jailing of blacks increased 7 fold. Blacks are 12% of the U.S. population--- and 53% of it's prison population. There are more Blacks enslaved under correctional control today than there were in 1850

Our communities are faced with. I can recite many more. Police, politicians, the legal system etc., stigmatize our communities everyday. They try to make us seem less than human. They campaign for mass-incarceration as the only solution. Playing on Caucasian Americans emotional pain, pitting their emotions against those of African Americans.

Surgically making excisions of all blunt language of racism, for anti-African American rhetoric.

Oppressing, and stigmatizing our communities is like a continuing trend from slavery, the Jim Crow era, up to the creation of mass-incarceration. These methods and techniques have been so intoxicating, that police are drunk on killing, and arresting African Americans. Courts are high on giving out long prison terms to African Americans. Prison systems are like junkies, fiendishly waiting and craving to inflict mental deterioration methods and techniques in the minds of African Americans. Knowing that the chances of re-entry will be very high. African Americans are engaged in a psychological war that they are not even aware of. Americans are being used as emotional pawns to carry out another's aberrant behavior. These are problems that effect our communities
