I believe the following pages will bring light to the problem America is facing. We must ask ourselves why is the U.S. imprisonment rate extremely high and why is the majority Brown or Black prisoners depending on where, at you are in the U.S. Borders.

This disparities in the punishment rates of Blacks and Hispanics and the current penal regime is somewhat to, the racial caste system of some third world country's. Our neighborhoods that are in large cities are at this time breeding grounds for Gang membership, and our prison system are the colleges for the future mass murders of America. Ask your self Why?

It is cause and effect - this is well been acknowledge as a Socioeconomic system. It was not so in the 30's 40's and 50's but since then the American dream has been destroyed the Family has been destroyed there are more single mothers and broken homes in America at this time then in the history of any other world power in known history. Shouldn't you want to know why?

As a current prisoner, Its been truly hard on the inside I've watched movies and then there are sitcom's

That show someones idea of prison life, they don't scratch the surface of what life is like. I lost a friend in 2003 to 2004 to a staff infection, there was someone who used that needle that had it. That's when I knew YAH was with me, let me explain I had gotten caught with tattoo items and then I was placed "in the Hole" Segregation for a month and my friend Dizzy went a few weeks after myself. I spent all 30 days in the Hole, and then went to Pod House at G.C.C.F. and Dizzy followed later and he came to me one day and bothered me to do a shot with him but I do not do drugs, "in prison anyway," we'll he wore me down and I said "yes," he got all happy and said I'll be back later, so we can party. Well when you do that stuff you don't remember anything or anyone, he went and did a Big shot with an Old School and that was that. He had gotten really sick in the span of 3 days, he was in a wheelchair and we knew he was dying, it was then Horizon Medical Health Care, and the whole pod started kicking the doors and beating the windows so they came and took him but it was too late he passed away on the way to the Hospital in Albuquerque. The Old School got saved but I got so upset that one of my friends had gotten sick.

And had died, I also got sick as it was my appendix that went bad. The very same nurse said I had "gas" by the third day I couldn't eat or drink or even walk so I told the officer in charge that I need to see a doctor or I was calling my family to get a lawyer, "That was a bluff my family don't really care," but it worked and they took me to medical and took blood and it was ready to burst...

Now comes the hard part they rushed me to the Hospital at Santa Rosa New Mexico and they said they couldn't help me so they made plans at Albuquerque St. Joseph Hospital for emergency surgery but they couldn't find an ambulance to come take me and they weren't going to pay to fly me...

Now it took them about 18 hours and finally the Captain at night said take the rover Van chain him up and put him in and take him to the Hospital. That was the longest 2 1/2 hours of my life. Now they took me in and the doctor said we've had your operation and doctor here for 15 hours, so they put me on the Roll away and I believe that my Appendix ruptured there or in the Van none the less, I stop breathing and died all I can remember is what the Bible says is out of "darkness" which means without YHWH presence

It was an awful place absent of light absent of every thing, woke up with a bag and hose sticking out of my side. I then recovered and fast forward in 2005 I paroled to my sister's Home in Colorado she made me violate and turned me into the police and thats how we find ourself here in prison.

This is were the prison system changed in that year they locked down the "clicksters" prison gang's The L.C.'s and the S.E.M. So the whole face of the system changed and not for the better but I came back in Feduary of 2006 I was what you may call insane as I was placed in the mental health treatment center newly built. This was an illegal thing as I have got new Felony's... I should of gotten to see the judge and assigned a public "pretender" defender but in the state of new mexico the judicial system does what it want's not what the law or Constitution says it should do. well at this so-called Hospital it was so awful from when the criminality insane. Woke up it was none stop bang on the cell doors people screaming and yelling cutting, rubbing feces all over them selves and there cells there was black water running of the tier as the would break the sprinkler

where broken it was pure Hell as when you acted up they would strip you naked and stick a needle in your butt and you'd go to sleep and wake up in the rubber room naked and afraid with only a small hole in the middle of the padded cell. you had to pee in the hole and use the other in the corner until you 72 hours were up that's how long you could stay. Well I finally started taking my medications and got better they moved me from crazy lock down to just lockdown at that time I was facing 5 1/2 years at 85% So I attempted to Commit Suicide by tying my shoe strings together and running them through the vent holes and hung myself "A warning to anyone who tries this", it failed because as soon as the strings tightened up around my neck my eye balls try to shot out of my eyesockets and the pain around my neck. Luckily the Strauge bend was still there so I stood on it and broke the shoe strings off. Well in that place its 24 hour lockdown and fifteen minutes rounds for the officers to make sure your not dead. When he came to my cell he called me over to the cell door and asked what's that bright red ring around my

neck was "I didn't know I received a rope burn," so I said quickly "O" it was my necklace I was allergic to the fake chain "he said sure it is," it's a perfect red ring around my entire neck, so after this I asked YHWH and Yeshua 'if you really real show me come to me and set me free from these demons in me. It matters not to me if you believe or don't believe I believe! That's what matters. So after that experience I was a 180° from what I was to what I will become... It was spoken I would become a preacher and preach the Gospel to the world. So this is where my life changed I only got 28½ years on paper 15 at 85% and 2½ at 50% and a 50% running with my 15 years at 85%, now I went back at the end of 2006 to Clovis Curry County. I was there almost 3 years I escaped and hit America's most wanted, so now it's a big case because of the television coverage. So when I'm sentenced to 15 years I get 2½ for the escape and as soon as I hit the line I was once again locked down from 2006 to 2011 and again in 2013 to 2015 but it's been hell for me and others as 24 hour lock-down takes a toll on you, but That's were my

Life could of been for vengeance against the public or I could of used it for my own good. So my personal choice was to educate my self with what was prophesied over me in 2002 by a priest from the rank's of Inmate's; he had spoken over me in a morning prayer session then my experience in 2006 February or March. So that is what I did when I was released from lock down due to a lawsuit by one of the other convicts I had escaped with, from Curry County detention center in 2008. I was sent to Santa Rosa which is the worst prison for violence in the STATE of New Mexico violence is hourly at that time. I had a personal relationship with YHWH, Yeshua; and the Holy Spirit and it was "Elohim" that taught me the Holy Scriptures and my personal Truth for 6 years it was 15 to 18 hours of study of the Scripture and over 100 ministries Bible Study's, I still do this every day. Not so many hours but I work towards the want for me to help my fellow man but for me I have fallen! I've hurt 3 people over the breaks of escaping lock down. This last person was caused by the Unit manager at Santa Fe South Facility when I began my Civil TORT

Claim filed against Corizon Medical Health Care this is the same company that miss diagnose my Appendix in 2003 and killed my Good friend. So I filed two separate lawsuits against P.N.M. and Corizon and thats when my worst problem imaginable happened, it was then I wrote to my Judge what was going to happen and that was 1 1/2 months of it happening like a domino effect it happend word for word. So what happened was I was moved out of a "pod" that I was safe at and placed in "pods" where there were child molsters, Rapist Criminal Informants. When I did nothing there was a problem between two other inmates. I was also removed into a gang pod and gang members. When nothing happened, they moved someone who I knew from Santa Rosa, He had told on me and another Inmate that we were running a store he lost me over \$200.00 dollars as inmates get between \$.20 to \$.75 an hour 2 to 8 hours a day that is a crazy amount of money so they moved him in and they asked me if I knew him I explained yes he was a piece of shit and Rat. I thought that was that but he had drugs and started selling it now that the prison gangs

are in lockdown Facility it's "ok" to be a Rat Rapist, Child molester etc. So I was told you don't have paper work to show it so he can stay. well when he wanted his money for his drugs that's when they started to find out who he was. well he was a child Rapist murder from another state so one day they the so called gang members knocked on my wall as I was in level 4 "I only got 4 hours outside my cell" he asked me if I could help him what it was the knew I had a piece of steel but they wanted to get rid of me and him as someone had tried to put a "Jacket" on me. But I've never had any dealings with the Guards or police or D.A. or even my own lawyer so that's why they did it do anything so he said it was him and my next door neighbor who was order to do the hit. So I knew I was next on the list so that next morning we attacked him we were shot 8 times had a Grenade thrown at us and tear gas used I still wear the scare of the shot gun Bear bag Round on my back. well they tried to shot me in the back of the head but I heard them cock the shot gun

and for some reason I moved my head the round nicked my ear but got the Inmate, I was attacking in the middle of his nose well when all was said and done we where taken out side and the Prison has a kind of gravel that has points on them and they knecled us in the gravel, the pain that comes from that I couldn't explain it, if I wanted. So while they had me and the Inmate who asked me to help... The guard Romero was Slapping him on the back saying we've been waiting two weeks for you to get that piece of crap shot gun and mash in hard everytime we let you out. He is a child rapist and killer. You did good I looked at him and said what the fuck is going on here, then the guard that had me said whats that smell, it smells like shit I looked backwards and down sure enough that Inmate had shit his uniform and I was covered with shit and blood, then to top it off they charged us for the gas, Bullet's, and grenades, so it cost almost \$100.00 dollar plus 10 years of Good time. But atleast now I'm Safer I'll be locked down again but the system has changed so I was

having a blessing from "YHWH" when I was at the North facility Maximum Security there were two Godly men named David and Fred and they asked me if I wanted to go to college and Seminary. I said yes and here I find myself at LETA County Correctional Facility it started off good but the system changed once again and the people in charge believe we are the scum of the earth. So they have taken education and now we have to pay for each course which is \$158.00 dollars to \$250.00 dollars they taken our T.V. channels and they have taken our Good time reward And medical is worst then ever. So as of right now prison is a powder keep. IN the 1980's may happen again it's such that "YHWH" has trained me I hold a Bachelor(s) in Theology "Magna Cum Laude" and I just recieved my Master(s) degree in Nontheistic Counseling "Summa Cum Laude" and Certified in Nontheistic Counselor and I hope I'm accepted into the Doctoral program for my Associates of Arts from N.M.J.C. I need 14 credits but YHWH has given me these Gifts like the knowledge of the law I know have 3 Federal 1983 Civil Rights Court

hearing and 1 Tort claim with another pending. It is to the glory of Yeshua that I've been able to fight off the lawyer's and medical staff and Administration attacks but I don't have these lawsuits for my self but for the whole prison population win, lose, or draw there are over 300 pending lawsuits against the State of New Mexico Corrections department and Geo Group and Corizon medical and now hopefully against Centurion Health care. If you the people could understand that the torture and Abuse inmates like myself are put through it would outrage most humane beings. The people must try to interact and change the minds of the Government that we are not throw away's but people. We only survive by sure will if you would help us we could be retrained and become Tax paying Citizen's but without help we have no choice but to survive at the cost of your home, your children, and your very life. I don't speak for all prisoners but some want change and A better life... The American dream! This is not the end of the story I will be sending more Essays also.

"In conclusion; The liberties of our country, the freedom of our Civil Constitution, are worth defending at all hazards; and it is our duty to defend them against all attacks. We have received them as a fair inheritance from our worthy Ancestors: They purchased them for us with toil and danger's and expense of treasure and blood, and transmitted them to us with care and diligence.
