VI. I. PT II KINROSS 300+

On September 10th 2016 a peaceful demonstration was escalated in to a act of defiance by the convicts; inmates alike. We rallied on the yard; stood ground in front of the control center organizations; religious sects moving as a unit. Trying to get our voices heard about the atrocious; sometimes laughable way the M.D.O.C. (Michigan Dept of ~~Corrections~~ Corruption) treats us; forces us to live inadequately. With slave wages, rotten food; psychiatric, dental; medical care that is close to non-existent. Our demands for media went unheard, as our cries for better wages, food; medical. No-one worked for four-days leading up to this point no porters, yard crew, kitchen staff etc... Trinity our sub contractor for our food service fed us cheese sandwiches; no hot meals to this point. Two pieces of cheese, a pat of butter, two pieces of bread; a apple for breakfast at 4:00am is not appealing, when you expect waffles. So set the march in place. There was to be no violence toward staff or other inmates; there wasn't except C.O.s to prisoner violence later on. We asked to be heard by the Deputy warden, the warden, we wanted our voice to be heard by the media. Our questions answered, our thoughts put into consideration. The MDOC has been stripping us of our way to exist whether it be property to a decent meal; health care. We stood ground wanting to be heard while in the back ground the E.R.T was filling the control center; the parking lot outside. They blew emergency count sirens four to six times while we waited for a response or a effort of action upon the KCF (Kinross Corr. Fac.) staff to come to middle ground. We agreed to a show of non-violence; went into our units for count. Count was taken, cheese sandwiches were passed out with in our units. Allowing unit staff get radio calls to abandon their post with in the unit while ERT surrounded all the units, bringing weapons into play brandishing full riot gear, 12 gage shotguns, gas, pepper guns, etc... This a blatant show of foolishness; dangerous play by the KCF staff. Threats lead to violence; violence to destruction. The next downs would result in fires, property damage, threats, ~~handcuffs~~ etc... Barricades were placed in attempts to slow ERT entrance, cameras destroyed, etc... Communication was cut via the phones; pay machines by control center staff. In the downs to come tear gas; pepper balls would fill the unit to the point where extraction would be necessary. Inmates with respiratory issues attempting to back out down the hall way lands raised in the "Don't shoot" gesture, only to be assaulted by a barrage of pepper balls to the back.

VI. PT II Extraction:

People ~~we~~ were herded out the emergency door like cattle, asked their name; zip cuffed; left to sit in front of the units. I myself was placed in steel cuffs; escorted to the chow hall, stripped, shackled; placed on a transport bus up to Marquette branch Prison level 5 (MDOC has a # system for security classification 1, 2, 4, 5. One being low 5 being high) Kinross is a level 2. by the morning there was about 200 of us there.

VI. PT III Tickets Here, step right up; get your tickets:

Everyone was issued invite to riot/striking misconducts; most found guilty with out proof or reasonable doubt. Lot of people weren't even outside, until later in the morning due to a little provocation from others while others stayed in due to personal matters (i.e., parole, points etc...) More the less innocent people were being found guilty without proof, or just by association. You were at Kinross you're guilty. We were issued sanctions 30-60 days put on JD-Seq; ~~most~~ security classes raised to level 4 or 5. A couple weeks later the 190 or so with level 4 points, rode out to level 4's. While the few of us remained, were moved to the old three where there's levels; incentives for good behavior (i.e. TV, phone, select commissary) after you reach a certain stage of the incentive program. If you didn't attend TV they would loan you one, one call a month; a bag of chips; a rack of cookies. Dose a hell of a lot for a mans psyche. Not to mention writing paper flows free (cell explain more about the paper issue soon). By early November the remainder's; myself were back in transfer. Our ~~security~~ security classification waved down; sent here to Oaks Corr. Fac. (E'F); placed on lay down status.

VI. PT IV "Welcome to Oaks, where we don't hide the fuck you's"

Oaks the level 4 that's really a level 6, thus ushering in a new set of issues, where staff is above law; policy don't mean shit. Also ensuring my vendetta with the MDOC stays alive. This is the point where my personal issues; grievances come in to play. Well when you're on laydown status in JD-Seq here at Oaks

V.I. PT IV 'welcome to OAKS WHERE WE DONT HIDE THE 'FUCK YOU'S' CONTI...

IF YOU HAD A PERSONAL TV YOU CAN GET IT IN YOUR CELL, BUT CAN YOU WATCH IT? NO, THEY REMOVED ALL THE CABLE OUTLETS FROM THE CELLS. SO YOU GET A NICE \$150.00 PAPER WEIGHT UNLESS YOU'RE LUCKY ENOUGH TO DESTROY 1/2 YOUR EAR BUDS FOR WIRE TO TRY TO MAKE A ANTENNA; BASED WHERE YOU LOCK YOU MIGHT GET A STATION OR 2. NOW I SEE THE PAROLE BOARD SOON; BEFORE YOU SEE THEM THE UNIT CONSIDER AIDS TO WORK WITH YOU TO DO YOUR P.E.R (PAROLE ELIGIBILITY REPORT) MINE WAS DONE WITHOUT ME; WHEN I RECEIVED IT, IT WAS ERRONEOUS; FULL OF BIAS STATEMENTS. SO I ASKED MY UNIT CONSIDER (CRUS/PC) TO ADJUST THE ISSUES. HIS STATEMENT WAS "TAKE IT UP WITH THE PAROLE BOARD" VERY PROFESSIONAL, SO I GUESS ALL SABOTAGE IN YOUR P.E.R HELPS ENSURE YOU STAY A LITTLE LONGER GOD FORBID, SOMEONE DO THEIR JOB DOWN HERE. I ARRIVED OVER MISSING STATE ISSUED CLOTHING THAT WAS IN THE LAUNDRY WHEN I LEFT MARQUETTE. I PUT IN SEVERAL QUARTERMASTER KITES IN THE MONTHS TO FOLLOW. I RECEIVED MY MISSING ITEMS LAST WEEK SO IT TOOK 4 MONTHS TO RECEIVE 4 PAIRS OF UNDERWEAR, 2 T-SHIRTS; 2 PAIRS OF SOCKS. I GRINED THIS ISSUE TO NO SKILL IN THE PAST. NOW, HAVE YOU EVER BEEN IN A LOWER LEVEL THAN 5 (WHERE PAPER WAS SUPPLIED WEEKLY) TO BE BROUGHT TO A LEVEL 4 WHERE YOU CANNOT PURCHASE PAPER; THE PAPER ISSUED OUT IS ONCE A MONTH ON THE FIRST SUNDAY; ITS 10 SHEETS OF COPY PAPER SO DONT KNOW LEGAL WORK, FRIENDS, FAMILY, OUTSIDE BUSINESSES TO WRITE. NOW I KNOW FOR A FACT THAT IN THE MANDELLA RULES APPROVED IN GENEVA; RE-APPROVED IN 2015 STATES PRISONERS ARE ALLOWED CORRESPONDENCES THROUGH MAIL; VISITATION (VIOLATION OF RIGHTS? COULD BE) THESE ARE JUST MY INJUSTICES FACED HERE AT OAKS SO FAR WITH IN THE 4 MONTHS. ~~SO~~ NOT TO MENTION OTHER ISSUES NOT MENTIONED.

VI. PT V THE SEARCH FOR SELF SUFFICIENCY:

HAVE YOU EVER HAD A JOB MAKING 1 1/2 CENTS AN HOUR? I HAVE. SO COMES THE CHALLENGES OF SAVING MONEY FOR A YEAR, HOPEFULLY TO GET 150.00 + FOR A TV, OR EAT COMMISSARY, GET SHIPPED, OR PUT MONEY ON THE PHONE OR ON TRAY; NOT TO MENTION ALL THE OTHER EXPENSES; NECESSARY THINGS TO HELP MAKE LIFE A LITTLE EASIER OR MORE NORMAL. SOME OF THE KITCHEN ISSUES COME WITH THE SUB CONTRACTOR WHETHER TRIMARK OR TRINITY AS YOU EXPERIENCE THERE STRUCTURES OF THEIR COMPANY; THE PEOPLE WHO THEY HIRE. THESE PEOPLE LOOK; TREAT YOU AS OBJECTS NOT PRISONERS. SO FAR THEM TO PUT ROTTEN FOOD; ~~NOT~~ NUTRITIOUS MEALS OUT TO STARVE THE POPULATION ISN'T A PROBLEM AS ITS NOT A REALITY TO THEM. THE DISRESPECT TOWARD THE PRISON STAFF IS UNBELIEVABLE.

HAVE YOU EVER HAD A TOOTHACHE FOR 2 WEEKS? I HAVE. IT TAKES 2 WEEKS TO GET A DENTAL EXAM. I MUST BE IN NEED OF A PARTIAL; ITS 4 MONTHS PAST MY 2 YEAR MARK. THEN THE MDSC HAS A UNORTHODOX PRACTICE OF EXTRACTING TEETH NOT ~~PUTTING~~ FILLING THEM. SO FOR A MAN WITH 6 TEETH ITS A MATTER; BITTER QUESTION KEEP TEETH TO EAT WITH? ~~AND~~ STRUGGLE THROUGH THE PAIN OR LET THEM EXTRACT; WAIT UP TO 1-5 WEEKS TO GET A PARTIAL OR A FULL DENTURE, THEN PREP I REQUIRE NEED & REPLACEMENT (VIOLATION OF THE 8TH AMENDMENT OR MALPRACTICE?)

that work for me including 1 of 2 anti-depressants the doctor stated I can't be on 2 medications with anti-depressant qualities. So I had to pick one or the other one of these medications also a sleep-aid in its chemical make up. For a insomniac its a perk (only if you can get it to work.) I asked my therapist why the Doc. would make a person choose between being depressed or catching a sliver of sleep? she didn't know, then I asked if she would ask the doctor to raise my dose she told me the Doc won't go past 30mg when the max dosage is 45mg so my choice is get all rest and be sad or don't sleep; be closer to normal. then I was on a medication which helped with RLS; they discontinued it without notice I grieved this issue to no understanding again malpractice, or violation of the 8th amendment.

Prison state is alive; well in AMERIKKA's prison machine for a anarchist activist who experiences these personal battles with no way to voice; speak for others who can't its even harder the prison machine preys on recidivists, not re-entry. This is a sad fact to any man/woman/child who enters the system. Programs that don't teach or deal with real life situations. No help to self-sufficiency or adjustment to life in public where violence is not a regular view in the public eye but not a experience, to everyday society. No mental health or SS/SD for a adjusting period, only placement in to jobless, crime ridden, depressing environments where ~~step~~ only assistance, is to hold the shackle to your ankle, & a bed roll in waiting. Truth in sentencing dose not apply in Michigan for some reason they get away with it. Oh we do have it, but its ignored.
