1992-1994- DRUGS → LEFT FIL DEAD

1995-1998 PRISON } → shot-up

2001-2004 PRISON } DRUG RELATED

2007-2009 PRISON }

2012-2015 PRISON

2016- PRES. PRISON → nearly killed

ALL DRUG RELATED. NO ONE CAN SAY THAT I DO NOT KNOW ABOUT THE DRUG AND PRISON LIFE.

Today, I AM SERVING YET ANOTHER SENTENCE WITHIN THE MICHIGAN DEPARTMENT OF CORRECTIONS (MDOC). THIS TIME IT IS ONLY COSTING THE TAXPAYERS \$1,232,854.00.

I HAVE BEEN MENTALLY ILL FOR MORE THAN 30 YEARS

AND HAVE NEVER REALLY UNDERSTOOD ANY OF IT. I TAKE MEDICATION, THEN STOP, THEN THINK I'M OKAY, THEN DRUGS, THEN PRISON. THIS IS MY CYCLE.

I HAVE NEVER RECEIVED INTENSE MENTAL HEALTH TREATMENT, BECAUSE LIKE A DRUG ADDICT, WHICH I WAS, I DID NOT WANT TO ADMIT I HAD A PROBLEM AND I DEFINATELY WAS NOT TELLING ANYONE ABOUT THE RAPE, ESPECIALLY A PRISONER OR PRISON STAFF.

FOR SOME REASON, THE "PEOPLE OF THE STATE OF MICHIGAN" KEEP SENDING ME TO PRISON AS THOUGH IF THE PRISON SYSTEM CAN RESOLVE MY MENTAL ILLNESSES. HOWEVER, THE MDOC IS NOT, NOR HAS IT EVER BEEN A MENTAL HEALTH AGENCY, THOUGH THEY HAVE MENTAL HEALTH STAFF AVAILABLE. FURTHER, MY MENTAL PROBLEMS ARE MUCH DEEPER THAN THE MDOC. THE MDOC ARE SURFACE PEOPLE.

PRESENTLY, I AM IN A "PRISON" PROGRAM CALLED "RTP" (RESIDENTIAL TREATMENT PROGRAM) FOR THE MENTALLY ILL.

IN REALITY, IT IS NO MORE THAN A REGULAR HOUSING UNIT, LIKE ALL OTHER PRISON HOUSING UNITS, BUT HAS A FEW MINOR DIFFERENCES. FOR INSTANCE, MENTAL HEALTH STAFF DARTS IN AND OUT BETWEEN 8⁰⁰AM AND 4⁰⁰PM. THE UNIT HAS ITS OWN MED LINE AND THERE ARE MORE WOMEN THAN MEN.

THERE ARE MANY REASONS, BESIDES MENTAL ILLNESSES, WHY PEOPLE (PRISONERS) ARE IN RTP, THEREFORE, I WOULD NEVER, EVER, EVER, EVER, TELL ANYONE MY PROBLEMS. NUMEROUS PEOPLE ARE IN RTP FOR:

- A. Protection
- B. THE DRUGS. THIS IS BIG
- C. THE WOMEN
- D. TO TAKE ADVANTAGE OF OTHERS
- E. THE SMALL PERKS
- F. THE D-47 OPPORTUNITY
- G. BECAUSE THEY ARE ACTUALLY - USUALLY SICK

People, like me, who show a outer that's much different ^{FROM} ~~FROM~~ ^{FROM} his inner will NOT get the help we need.
