

## 5. History OF A Nigger

Beginning in the 15th century and ending in the 19th century. Roughly from about 1444 to 1845 a period of 400 years. It has been estimated that 900,000 Afrikans were imported in the 16th century, 2,750,000 in the 17th century, 7,000,000 in the 18th and 4,000,000 in the 19th centuries. (4)

### Purpose of Restrictions

Recommended that blacks be socially excluded.

Authorized branding of an "R" in face of runaway slaves.

Bared blacks from all trades

Prescribed banishment for any white woman marrying a black.

Prohibited blacks from holding or assuming any public office.

Rewarded slaves with freedom for informing on other slaves.

Criminalized runaway slaves to protect owners investments.

Forbade and criminalized black-white marriages.

Forbade and criminalized black-white marriages

Forbade blacks from keeping weapons

Impeded blacks from meeting, having a sense of community

Forbade slaves from raising or owning farm animals.

Allowed sale or execution of slaves attempting to flee.

## Colonial Black Enslavement (7)

- Black Slaves had no rights
- Most religions supported Black Slavery and intervened on behalf of the Slave holders, offering Biblical justification.
- Black Slavery was permanent and inherited
- European nations and Colonial powers conspired to manipulate and enslave blacks in order to develop the New World and Colonize Africa
- Slave holding was used as an essential component of capitalism, it empowered even the poorest white to acquire wealth.
- Black enslavement did not result from financial indebtedness, war religious persecution. Blacks were enslaved because they were black.
- The skin color of the Black Slaves was sensationalized and made in a badge of degradation and permanent inferiority.
- Colonial Slavery initially targeted Indians and indentured white servants, then blacks.
- The Blacks were psycho-socially conditioned to despise themselves racial disunity was rewarded.
- Slavery provided wealth for nations and institutions; empowered an industrial revolution and brought modern capitalism to Europe.
