Today is Oct. 5, 2020, & practically all year

I was Finally able to buy a TV in Feb. 2020. Befor that I listened to a radio I got in 2012. For years all I had was W.G.N.: Walls Going Nowhere.

Its a sad existance! Concrete & Steel Zaps & drains a persons energy like a battery on the garage floor. Racing thoughts plagued me from my past. I still have no emotional or financial support From family or Friends.

Trump made it back to the Whitehouse & mainstream medias going crazy. The Faces on Vegas PBS look like their diapers are loaded.

I believe the P.O.T.U.S. has been targeted by the
