

RECONSECRATING THE U.S. ECONOMY OF HUMAN WAREHOUSING

VARIOUS REPORTS PLACE U.S. PRISON POPULATION BETWEEN 1.5 AND 2.2 MILLION INDIVIDUALS - SOMEWHERE BETWEEN 4 AND 6 1/2 % OF THE U.S. POPULATION! THESE INCARCERATED PERSONS CONSTITUTE THE BACKBONE - THE SIN QUO NON - OF THE INDUSTRY OF MASS INCARCERATION (OR CORRECTIONS TO USE THE POLITICALLY PROPER TERM) WHICH CONTRIBUTES APPRECIABLY TO THE NEARLY 2 TRILLION DOLLAR U.S. GOVERNMENTAL INDUSTRY. DRUG OFFENCES AND CRIMES FUELED BY ILLEGAL DRUG MARKETS AND THE PREVENTABLE CONSEQUENCES OF DRUG USE AND ABUSE REPRESENT A SUBSTANTIAL PERCENTAGE OF THIS MASSIVE U.S. PRISON POPULATION. EXACT STATISTICS ON THIS PERCENTAGE WOULD BE NEARLY IMPOSSIBLE TO COLLECT GIVEN THE UNPRECEDENTED DIFFICULTY THAT WOULD BE INVOLVED IN EXAMINING THE DETAILED FACTS OF EACH AND EVERY STATE AND FEDERAL CASE IN THE ENTIRE UNITED STATES. BUT IF ONLY 10% OF VIOLENT CRIMES, PROPERTY CRIMES AND PUBLIC ORDER CRIMES CONTRIBUTE TO THIS SELECTION, THEN THE PERCENTAGE OF INCARCERATED PERSONS IN THE U.S. WHOSE CRIMES RELATE TO INEFFECTIVE DRUG REGULATION IS NO LESS THAN 30% - THAT IS TO SAY THAT NEARLY NEARLY ONE IN EVERY THREE INDIVIDUALS INCARCERATED IN THE U.S. AND WAREHOUSED IN AN INDUSTRY WORTH HUNDREDS OF BILLIONS OF DOLLARS, IS IMPRISONED AS A RESULT OF DRUG LAWS.

THE QUESTION IS, THAT WHAT IF THEY WERENT? GRADUALLY, U.S. CONGRESS AND STATE LEGISLATORS HAVE GRUDGINGLY BEGUN A PROCESS POPULARLY COINED "DECRIMINALIZATION" OF DRUGS. THIS DIRECTION (WHICH FOR REASONS BEYOND THE SCOPE OF THIS ARTICLE IS OXYMORONIC, ITSELF, IN NATURE) SEEKS TO GRADUALLY DISMANTLE THE CURRENT DRUG- INCARCERATION CULTURE IN AMERICA. BUT WHAT ABOUT THE INDUSTRY OF MASS INCARCERATION? IS IT GOING TO BECOME A THING OF THE PAST? IS GOING TO GO EXTINCT IN A NEW MORE PERMISSIVE WORLD? REST ASSURED, GOVERNMENT (AND PRIVATE INDUSTRY AND MOVIE INDUSTRY WHICH PROMOTE POPULAR TV. SHOWS PRODUCED BY DICK WOLF LIKE NEW YORK UNDER COVER SVP UNIT AND CHICAGO PD) LOVE THEIR RAT LITTLE PIGGY BANKS KNOWN AS MASS INCARCERATION - A HEAVY-ROBUST HOG THAT REQUIRES VERY MINIMAL MAINTENANCE IN RELATION TO THE MASS INDUSTRY THAT HOVERS AROUND IT TO SUPPORT IT. UTILITIES, PHARMACIES, AGRICULTURAL, MANUFACTURING, HEALTH CARE, INSURANCE, AND FINANCE ALL SERVE AND SERVE THE SACRED GOLDEN COW OF INCARCERATION, AND THIS IS TO SAY NOTHING OF STAFF, ADMINISTRATION, AND OF COURSE MILITARIZED AND POWERFUL LAW ENFORCEMENT AND THEIR ROCK SOLID POLICE UNIONS INTRINSIC TO THE INDUSTRY. ALL OF THESE BENEFIT FROM MASS INCARCERATION - AN ENTIRE ECONOMY BUILT ON SLAVE LABOR AND THE BACKS OF PRISONERS. SO THEN, THE QUESTION BECOMES: HOW IS MASS INCARCERATION EXPECTED TO SURVIVE THE MASS

"DECRIMINALIZATION" OF DRUGS? WELL, FOR THIS, LETS ASK A DIFFERENT QUESTION - ONE THAT CONCERNS NOT THE SURVIVAL, BUT RATHER THE NATURE OF PRISONS - AND A QUESTION THAT OUR TIRELESS, VIGILANT CORRECTION CZARS, OR SHOULD I SAY PRISON ADMINISTRATORS MIGHT CONSIDER OF UPMOST VALUE: HOW DO WE MAKE PRISON BETTER? THIS QUESTION CAN EASILY BE BROKEN UP INTO THREE COMPONENTS: 1. LETS MAKE MASS INCARCERATION MORE LUCRATIVE 2. LETS MAKE IT MORE MANAGABLE AND 3. LETS MAKE IT MORE POPULARLY APPEALING TO THE PUBLIC.

BUT HOW...? LUCKILY, (WHICH MEANS BY DELIBERATE DESIGN) A TAILOR MADE SOLUTION TO THIS PROBLEM ALREADY EXISTS: THE SEX OFFENDER. LET HIM BE THE SCAPEGOAT, VILLIAN AND SOLUTION. SEX OFFENCE LEGISLATION HAS GAINED WIDESPREAD POPULAR SUPPORT ACROSS AMERICA (AND EVEN INTERNATIONALLY) THROUGH MASSIVE MEDIA CAMPAIGNS, POP-CULTURE, SENSATIONALIZED POPULAR TV CRIME SHOWS AND RUTHLESS FEAR MONGERING; ALL WITHOUT JOHN Q. PUBLIC EVER BEING FULLY APPRAISED OF WHAT A SEX OFFENSE REALLY CONSTITUTES. THIS HAS RESULTED IN AN IMMENSE SEX-OFFENDER POPULATION; VILLIFIED PIRIATHS DEPRIVED OF CONSTITUTIONAL RIGHTS, SUBJECTS OF SEVERE OSTRACIZATION, HUMILIATION, AND UNKNOWN TO MANY, SUBJECT TO THE "DECRIMINALIZATION" OF MANY ORDINARY PASTIMES AND ENJOYMENTS (WHICH PRACTICALLY ENSURES FUTURE CRIMINAL PROCEEDINGS FOR DAY-TO-DAY ACTIVITIES NORMAL AMERICANS TAKE FOR GRANTED).

AND DID YOU KNOW, IT IS ALMOST IMPOSSIBLE FOR PROSECUTORS TO FAIL AT GETTING A CONVICTION AGAINST AN ALLEGED SEX-OFFENDER. THAT'S RIGHT. NO DNA IS REQUIRED. JUST A ONE SIDED STORY. SO TO ALL OF YOU READING THIS WHO THINK IT'LL NEVER HAPPEN TO YOU, YOU'RE ALL JUST ONE BEER, ONE BAD BREAK UP, ONE SCHOOL YARD OR OFFICE FIGHT FROM BEING ALIENATED AND PLACED ON THE SEX-OFFENDER REGISTRY FOR LIFE...

So, THE WAR ON ALL THINGS SEX (AND BEYOND) THAT HAS BEEN CONTINUALLY WAGED FOR DECADES IN MEDIA, POLITICS, GENDER WARS, AND LEGAL ARENAS HAS ALREADY ACHIEVED THE POPULAR STANDARD FOR IMPROVING PRISONS AND MASS INCARCERATION IN THE PUBLIC EYE. NOW, WHAT ABOUT THE OTHER TWO STANDARDS: LUCRATIVENESS, AND MANAGABILITY? OBVIOUSLY, THESE TWO GO HAND IN HAND AND, OF COURSE, THE SEX OFFENDER FITS THE BILL PERFECTLY FOR SATISFYING THESE POINTS TOO.

MANAGABILITY OF PRISON POPULATIONS IS OBVIOUSLY THE MOST CRITICAL AND DIFFICULT ASPECT OF OPERATING AND RUNNING A PRISON. A PERFECT ANALOGY HERE WOULD BE THAT ITS FAR EASIER FOR ZOO KEEPERS TO MANAGE A PETTING ZOO THAN IT IS FOR THEM TO MANAGE A ZOO BRIMMING WITH LIONS, TIGERS AND BEARS.

IN PRISON, SEX OFFENDERS HAVE A WELL ESTABLISHED REPUTATION FOR BEING EXCEEDINGLY DOGILE AND COMPLIANT, EVEN UNDER THE MOST ADVERSE CONDITIONS. (OFTEN THIS RESULTS FROM FEAR OF ABUSE AND INTIMIDATION FROM CORRECTIONAL OFFICERS AND OTHER PREDATORY VIOLENT DOMINANT PRISONERS AND RUTHLESS GANG MEMBERS). FOR INSTANCE, IN DAYS OF YORE PETTY SLIGHTS FROM PRISON STAFF COULD EASILY PROVOKE MASS RIOTS BY SHORT-TEMPERED VOLATILE AMPHETAMINE OR HEROIN ADDICTS IN PRISONS. BY CONTRAST, YOU WILL NEVER SEE AN EXAMPLE OF A RIOT BREAKING OUT IN A PRISON PREDOMINANTLY POPULATED BY SEX-OFFENDERS, NO MATTER HOWEVER STAFF AND POLICE MAKE ~~THEIR~~ THEIR CONDITIONS OF CONFINEMENT UNBEARABLE. SEX-OFFENDERS ARE MUCH MORE INCLINED TO FILE GRIEVANCES, LAWSUITS, OR (MORE OFTEN THAN NOT) SIMPLY SUBMIT TO THEIR PLIGHT. FOR, THE FINAL STANDARD, THE LUCRATIVENESS OF A PRISON, THOSE WHO UNDERSTAND SEX CRIMES - THEIR SCOPE, THE HARSH LENGTH OF SENTENCING, THEIR EASE OF CONVICTION, AND THE SUSCEPTIBILITY TO FUTURE CONVICTIONS, THEY OPEN UP. THEREFORE, IT IS QUITE EASY TO SEE HOW PRISON POPULATIONS CAN BE SUSTAINED AT ANY LEVEL DESIRED INDEFINITELY WITH MINIMAL TO NO EFFORT IN TERMS OF MANAGEMENT. AN INDUSTRY OF WAREHOUSED HUMAN SLAVES SUPPORTED BY A MASS INFRASTRUCTURE OF AMERICAN INDUSTRY THAT CAN EXPAND OR DIMINISH AS ECONOMIC NEEDS NECESSITATE - A SORT OF LIVING, BREATHING ECONOMY "OF THE FLESH". SERIOUS STUDENTS OF ECONOMIC THEORY AND HIGH FINANCE WILL IMMEDIATELY SEE PARALLELS WITH THE MORE ABSTRACT ECONOMIES OF AGRICULTURE, PRODUCTION, SHIPPING ETC.

SO WE HAVE AN INTERESTING SITUATION THAT AS THE LAW GIVETH (BY CREATING AND EXPANDING A SET OF OFFENSES WHOSE LEGAL CONSEQUENCES MAKE IT IMPOSSIBLE TO HAVE MEANINGFUL LIVES OUTSIDE OF PRISON WITHOUT AN EVER PRESENT FEAR - A SWORD OF LEGAL DAMACLESSE - HANGING OVER THEIR HEAD AND ~~WRAP~~ WHOSE BREADTH OF LEGAL CRIMINALIZATION CAN REACH SO FAR THAT IT IS IMPOSSIBLE FOR EVEN THE MOST RESPECTABLE MEMBERS OF OUR SOCIETY TO AVOID ENTRAPMENT).

I SHOULD KNOW, BECAUSE I MYSELF HAVE FALLEN INTO THIS TRAP AS THE RESULT OF A 1997 FALSE ALLEGATION WHICH RESURFACED WITHOUT ANY DNA OR NEW EVIDENCE DURING THE METRO ERA SHORTLY AFTER OCT 2008 AFTER I REPORTED POLICE CORRUPTION TO FBI RESULTING IN THEIR 2012 ARRESTS. 2.

THIS IS THE FUTURE. AS DRUG LAWS

GO OUT, SEX-OFFENDER POPULATIONS WILL QUITE MAGICALLY RISE TO THE EXULTANT APPLAUSE OF THE FEAR-BLINDED PUBLIC THAT GOVERNMENT LAW ENFORCEMENT, AND PRISONS ARE KEEPING THOSE DANGEROUS, SEX MADDENED RAPISTS AWAY FROM THEIR WIVES AND CHILDREN. THE MASSIVE WHEEL OF THE MASS HUMAN TRAFFICKING AND WAREHOUSING INDUSTRY WILL GRIND INEXTRICABLY FORWARD, AND NO ONE WILL EVER KNOW ABOUT ANY OF THE SUBTLE MANIPULATIONS OF IT ALL, EXCEPT FOR THOSE WHO BECOME ENTRAPPED AND THE VERY PERSON WHOM THIS ARTICLE HAS IMPRINTED UPON...
