If I or someone I am trying to assist is harmed simply because one of the unprofessional few is unable to logically counter the fact that "Inmate" is a derogatory term meant to dehumanize a man, woman or child so it is easier to abuse, neglect or simply to ignore their hurt or needs [and deny their intrinsic value as human beings] I vomit. I throw up when I simply hear of "Inmates" hurting or stealing from SMI patient/prisoners in Dixon's Psychiatric Unit and Special Treatment Center or discover a suicide could have been prevented; degrading or torturous treatment avoided in either of the prison's sections; or not given a chance to attempt to change a little of the negativity into a source of creative energy to help others laugh or, at least, smile [because an unprofessional few won't let a Christian/Judaic poem or work of prose "out" of the institution, nor a political parody, joke and/or cartoon "out" and, thus, give me a chance to earn enough to provide for my needs,] well, I slowly vomit my life away. I'm malnourished & enfeebled because I accidentally stopped being 100% self-centered, and somehow grew to care about what happens to others and the negative ripples a thoughtless word or deed always leaves behind.

I'll send you copies of things sent to you and your colleagues in the past by more than a single route if I can. Either scan, share and return them so I may see what exactly was received or, please, keep them if they can be utilized to help any of the mentally hurt patient/prisoners here.

If you or anyone can help me to E-mail or use normal mail successfully I will be happy to supply you with additional legal work, etc., to assist with protecting men, women and children in every state. (If something "unforeseen" should happen to me please see no one else suffers through similar neglect, abuse, retaliatory torture or degrading treatment. Thank you, Bob Covelli R.F.C.

"Select medical [and other information] is being excluded from the medical records," Other material "logs", altered and/or "sanitized" records are being readied to try to justify the unjustifiable decade or more of injuries that may be the end of me. I pray no one will snatch at any excuse not to insure no one need go through this again
