As I sit here in county jail awaiting sentencing for crimes I didn't commit, I remenisce on my imprisonment inside $A Z$ 's broken and corrupted penal system, And I think about their attempted assassinations Ide survived.

I have been incarcerated in the $A D C R R$ nearly my entice adult life, since 2006 , subject to it's racist, murderous ways, and have survived. Like most politically conscience prisoners, I know how the ADC uses racial factions to control the masses, ind to keen us divided, puppeteerina the "heads" of self-serving gangs like the Ewe and the AB. I' knew this at a wing ane, which is why, in 2009 , myself and two comrades founded an ornanization to combat not only the corrupt prison officials, but also the banns those officials manipulated. Slowly we arew, and, to this day, arestill growing. The ADC's intelligence units, SSU and STG; have never been able to identify our organization's name or its members, but they knew the seed was planted, and growing. In 2017 I learned, through a denary warden, that, by way of intel aifted to the $\theta$ nemy, I am on the Mexican Mafia's hit list. That dian not deter me. Unable't to label our arounD, STG falsely labeled me as a member of Esquina Familia' Dosé. Then things escalated. Trans fering me to a PC unit against mu will in 2018 , ADC sent its hitmen twice, and twice, though briefly hospitalized one of the times, I survived. But the ADC wasn't through - they probably never will be. Conscience of the strenath of inc organization, the ADC tried another way to assassinate me: death be imnlisonmont. Dir. David Shin, who took ADC's reigns from Charles" Vadde" Ryan in 2019, has levied 15 new felony, charges of assault on a C.O. against me. Each charge carried between 3.5 and 7.5 years in prison. But I survived. By the grace of a higher power, my penpal-turnedfriend bought me a private lawyer, and my upcoming sentencing will result in no time added to mu incarceration. But assassins must be persistent. And so when I 'eave this county (maricopa) I must ac and fight EVEN MORE bogus assault charges in vet another county (pinal), this time with a depleted lenal defense fund. The State is doing everything in its power to assassinate me - my reputation, my spirit, my very life -desperate to 1 of 2
forever keep an awakened mind imprisoned. I write today because tomorrow I might not be able to. Ill return to ADC soon, where their officials will likely look for the coup de grace. For now, I continue to survive and resist. Because in the words of Dr. Martin Luther King, Jr., "To cooperate passively with an uniust system makes the oppressed as evil as the oppressor."
