Many also intentionally use the Law against people for their own benefits and gains. A Law suit is any action or proceeding in Court to be adjudicated by a Magistrate or Judge by Judicial Rulings. A Judge is a Government Elected OR Appointed Political

Then you're FORCED to go to school where you are detained (imprisoned) and cannot leave. Most schools are Authoritarian and focus priority on FORCED Obedience and Rule adherence in FORCED education.
