Yet we are left to grasp for answers on our own. However, this does not mean that we ARE alone. There ARE people who will help us. And there are people who will help us find the right people to help us.

Regardless of our thoughtful insights and careful preparations, it is impossible to have a contingency plan for every imaginable scenario. Sometimes things happen that totally baffle all logic and understanding. Such was the case three years ago. I was on the toilet, in MY HOME, in MY BATHROOM. Three men came in with BURGLARY/ROBBERY - on their agenda.

Yes, there are laws that say folks can't do that. There are even laws which state you have the RIGHT TO DEFEND YOUR LIFE AND PROPERTY IF PEOPLE COME INTO

YOUR HOME AND ROB YOU. (TEXAS PENAL CODE § 9.41 is called:)
JUSTIFICATION EXCLUDING CRIMINAL RESPONSIBILITY!

But try telling that to the corrupt officials who run Burleson Texas and Johnson County.

By now I'm sure everybody has heard of the: ETHAN COUCH "AFFLUENZA" case, where this kid from a very rich and prominent family KILLS FOUR PEOPLE and is only given 4 years probation. (Then him and his mom promptly fled to Mexico!) Well, I lived in Burleson too! The only problem was: I WAS POOR! Department of Justice; State Bar; Innocence projects; lawyers; advocacy organizations; etc... and for some reason - people avoid Johnson County Texas. They won't give me any of my files or court papers. They won't answer mail. They won't do NOTHING - because they think they're ALL POWERFUL, above the law, and they know I ain't got nobody on my side.

Please keep me in your thoughts and in your prayers. Please help me find somebody to help me. They are willing to break the law in order to feed this TEXAS PRISON INDUSTRIAL COMPLEX. CORRUPTION MUST STOP - and JUSTICE SHOULD NEVER BE FOR SALE TO THE HIGHEST BIDDER!
