Dear Friends,

I hope this letter finds all of you doing well. Things are fine here with me. Please allow this letter to constitute express written permission to publish and or forward anything I send you. The ad in the PRISONER ACTIVIST RESOURCE DIRECTOR said a PERMISSIONS QUESTIONNAIRE MUST accompany all submissions. I hope this letter will suffice as both.

I am 50 years old and have Autism Spectrum Disorders. I feel blessed to have made it this far in life. I've always had to try so much harder than others did just to be "ALMOST-NORMAL". I'm not complaining. There's just been some things that adversely affected my life. BULLYING was one of them. And the civil, human, and due-process rights violations within their "SO CALLED SYSTEM" are others.

I've never been one to go out and commit crimes. All of my problems arise from my "fight or flight" response causing me to over-react in stressful and dangerous situations. Here is a brief summary of why I've come to prison in the past.

• (2000-2002) POSSESSION OF A PROHIBITED WEAPON: Back in 2000, my roommate and a friend of his came back from deer hunting drunk and hopped up on pills they'd brought back from Mexico. They each had a rifle and a pistol (.30-06 + .357 magnum - 9mm + .30-30 respectively). They got rowdy and tried to fight me in my own home. I diffused a volatile and dangerous situation by brandishing and firing a "warning shot" from a weapon of my own. (SAWED OFF) Texas will put you on probation for a weapons charge. They'll send you to prison for marijuana.

• (2007-2011) AGGRAVATED ASSAULT WITH SERIOUS BODILY INJURY  
When my 11 year old stepdaughter was being molested by her pedophile grandfather, I threatened to cut his dick off. When my fiancée told me he'd done the same sick





shit to her when she was a little girl... well two generations of shattered lives had to stop. I beat that son-of-a-bitch half to death. I didn't cut his dick off. She stopped me before it got that far. Long before there was #ME TOO - THERE WERE MEN LIKE ME!  
I WILL FIGHT FOR MY FAMILY AND MY HOME!

(2015 - 2040) AGGRAVATED ASSAULT WITH DEADLY WEAPON

I AM CURRENTLY SEEKING PROFESSIONAL ASSISTANCE TO APPEAL THIS WRONGFUL CONVICTION! On April 25<sup>TH</sup> 2015, three men came in my home and robbed me. I was on the toilet when they come in. I immediately gave chase and tried to retrieve my property (wallet + phone). There was 3 of them against ME. I used a hammer to even the odds. TEXAS PENAL CODE § 9.41 is called: JUSTIFICATION EXCLUDING CRIMINAL RESPONSIBILITY (Otherwise known as the Castle Doctrine) It is not illegal to defend your life and property. Here are just a few of the things they did wrong to violate my rights.

- CONSTRUCTIVE DENIAL OF COUNSEL - I was denied an attorney for 4 months and never allowed a lawyer at questioning [Miranda v. Arizona - Strickland v. Washington]

- WITHHOLDING OF EXCULPATORY EVIDENCE - Everybody knew it was a ROBBERY/BURGLARY gone wrong. The D.A. refused to give that info to the Grand Jury. [OBSTRUCTION OF JUSTICE - Brady v. Maryland]

There's way too much stuff wrong with this case to mention in this initial letter. I just want people to know that Texas uses its CORRUPT "criminal in-justice system" as a default mechanism for its broken mental healthcare system. Just read the other stuff I've sent you.
