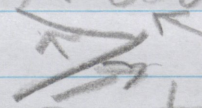


Hello: APWA

This Essay is on Orange County Jails, in fact I've lived in The Lacy Facility in City of Orange CA. in 2007. (No Heating System for detainees and Inmates, only Cold Air blows out Vents. The City of Santa Ana, CA. Has (3) County Jails connected to each other, I lived in each building, 1st building was Central Mens Jail (5) Stories High, a Concrete & Steel made, NO Heating Systems threw out the Entire Building. There are intake blowers on 5th floor Roof, that takes in Air which Blows out Cell vents & dayrooms. it's a Rule NOT to cover vents. There are ALOT Seniors in these Jails, But deputies don't care. The Air is so cold in here my fingers turn light Blue, and were only allowed 1 thin blanket, not warm enough to block the cold, See Concrete gets cold 24/7 Steel too, so its like a Ice Box or walk in freezer. With the MOUNTAINS to the East of Santa Ana (by 50miles) it gets extremely cold at night

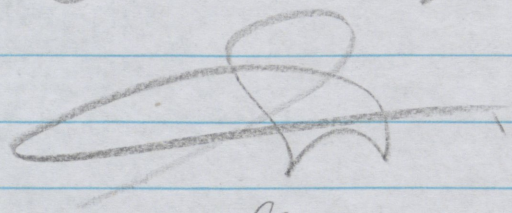
the 5th floor is Recreation only but deputies has Grills up there to Grill whatever, the 4th floor is called Fox, Alpha, Beta, Echo, 3rd floor delta & Charlie those 2 floor are multi cell units 60 Plus double bunks, Still no heat, to get to any floor in the five story Jail, you can travel up the escalators on a zig zag  one going up, one going down, or travel up utility Elevators Large enough to fit (10) - double door Refrigerators, easy, the 2nd floor consists the bridge to travel to the other Two Jails (JRC) Intake Release Center a 2 story Building connected to the five story unit Plus 2 story unit called Central Women Jail or Women's Annex Jail Only 2 floors for Housing, this is where I live now, temps are about 60° to 67° in the day 50° to 60° at night, you boss be wearing double T-Shirts to bed, my unit. 15 I mod consists of 2 floor 4 cells upstairs 4 cell downstairs Single man cells with 1 vent per cell, which are over I took Saran wrap to cover my cell vent. Im 64 my skin is thinning As I age. Consider older detainees & inmates especially the women which are in

ARE IN IRE Only. AS I
 HAVE BEEN affected by many
 ISSUES, Flying Roaches come
 in the vents crawling on
 your food + body. The water
 is Recycled, not made for
 Public use. in fact deputies
 told by Sheriff Don Barnes
 NOT to eat the food and
 NOT to drink the water. I
 personally heard him say
 it. I have witnessed a Truck
 loaded of Sparklets water
 Bottles, (5-gallon Bottles) given
 to just the deputies &
 medical staff. we drink
 Bath, Cook, with cantam-
 inated water. the same
 water we use the toilet with
 and they wash our clothes
 with. go figure. The Paint
 on the Steel Bars has lead
 in it. Air vents has Esstest-
 as remember OC Jail was
 opened in 1961. The (3) Jails
 sits in the Heart of the City
 Homes to the East + West + North
 + South. my Prison term was
 2 yrs 8 months in 2008 I did
 2 yrs in Prison. Paroled out in 2010

Right into this County Jail
I've been here since. In
October, 2013 I discharged
off Parole. Yet I'm still here
in Jail unArrested, uncharged,
for anything. its been now 15 years
since 2008, and 12 yrs since
2010 when I came here, and 9
years since I discharged
off Parole.

I just want to go back home
to Chicago, with family. But
I pray to Jesus Christ every
night before bed, to get sent home
to Chicago. I do plan upon release
to Travel home, get Residence, &
file for a Grant to open a franchise
with Subway where I can
establish jobs for the Community,
donate Subs to Homeless & Elderly,
and donate a cash fund to Child Cancer.
