Title: EXPOSE CORRUPTION OF C.D.C.R. FOR JUSTICE REFORM

THERE IS A ALTERATION OF MAIL, FALSE LABELS, THE OBSTRUCTION OF COMMUNICATIONS TO LEGAL ASSOCIATIONS, GOVERNMENT ACCOUNTABILITY OFFICES, CONCERTED ACTS BEING CARRIED OUT BY C.D.C.R. EMPLOYEES. THESE ACTS ARE DEFINED AS FEDERAL CRIMES BEING CARRIED OUT AGAINST CALIFORNIA INMATES OBSTRUCTING ALL VENTURES THAT SEEK LEGAL ASSISTANCE OR ACCOUNTABILITY AGAINST THOSE ASSOCIATED TO LAW ENFORCEMENT.

FOR THOSE THAT MAY NOT BE AWARE OF THESE FACTS OR EVIDENCE, EACH OVERSIGHT AGENCY OF PRISONS OR LAW HAS A LEGAL DUTY TO INVESTIGATE CRIMINAL OR ILLEGAL ACTS REPORTED AS VIOLATIONS OF THE LAW TO BE CONCLUDED WITHIN A SHORT TIMEFRAME. THE SIMPLE FILING OF A REPORT REQUIRES A INVESTIGATION NUMBER AND IDENTIFICATION OF THE PERSONS TO INVESTIGATE THE SPECIFIC ALLEGATIONS, THEN FINDINGS AND CONCLUSIONS OF EACH INDIVIDUAL VIOLATION.

SPECIFIC INMATES TARGETED BY CDCR AS A DEPARTMENT, ^{THOSE} DESCRIBED AS LITIGATORS, THOSE WITH EVIDENCE OF INNOCENCE, OR MATTERS THAT ARE TO HOLD CONSEQUENCES AGAINST LAW ASSOCIATES ARE "STONE WALLED". THIS SAME STONE WALL HAS BEEN IDENTIFIED BY THE CALIFORNIA OFFICE OF INSPECTOR GENERAL AS, "A TIGHT-KNIT SOCIAL SOCIETY" WHICH HOLDS NO DISTINCTION FROM "THE GREEN WALL".

THIS SECRET GROUP OF INDIVIDUALS INTENTIONALLY FABRICATE MAIL LABELS, PREVENT COMMUNICATIONS TO THOSE THAT PROVIDE LEGAL ASSISTANCE TO INMATES THAT SEEK JUSTICE ACROSS CALIFORNIA. THE INMATES WHO NOTICE THESE FACTS AND HAVE BROUGHT THESE ACTS TO THE COURTS ATTENTION AS VIOLATIONS ARE CONTINUOUSLY DIVERTED BY THE FEDERAL JUDGES, AS FEDERAL LAW VIOLATIONS. SOME INMATES ARE MISLEAD UNDER THE FALSE INTERPRETATION THAT THEY DID NOT RECEIVE RESPONSES UPON SPECIFIC REQUEST FOR LEGAL ASSISTANCE.

THE PUBLICS HELP IS STILL NEEDED TO EXPOSE THESE ACTS OF CORRUPTION BY SHARING ON SOCIAL MEDIA, SIGNING THE PETITIONS TO OBTAIN THE F.B.I.
