MENTAL HEALTH OPPRESSION

The all white Administration at this Institution (Santa Rosa C.I.) and Secretary Office (Central Office of D.O.C.) has been inflicting covert racism and passive styled Retaliation and Discrimination through spiteful systemic schemes to Blackball me and attack me in malice.

This is being orchestrated by them conspiring to Deprive me of Grievance Procedure by Denying or Obstructing Every grievance I file in Blatant Indifference and Discrimination to All policy stipulations/provisions of the Florida Administrative Code under Title 33 authorized by Florida Statutes. It is being done so extremely that it has become tantamount to completely usurping/eliminating my 1st Amendment rights to petition the government for redress ~~of~~ grievances and curtail me from seeking or expecting Any Fair Remedy for legal or procedural violations made against me.

A simple review of my extensive Grievance Record will confirm the ~~malicious~~ above malicious conspiracy inflicted upon me. This is ~~because~~ ^{because} I am too destitute to afford any kind of legal assistance or representation. This has condoned and encouraged over 100 falsified bogus disciplinary reports written against me over the course of the past (7) years. I've been illegally confined on Close Management 1, (CM1) which is 24 hour solitary lockdown. Then once I Challenge the Invalid D.R.'s in the Courts, the Court imposes illegal fees and excessive liens on my inmate account then Dismisses my Petition stating that "Since I'm serving a life sentence I have no liberty interest and no legal rights to challenge any disciplinary reports."

These type of Legal rulings were created because the Florida Department of Corrections is the biggest business in this State generating the money to dominate the Politics in this State.

It has been scientifically ~~proven~~ proven that long durations in

Confinement causes mental illnesses which I've developed many of over the past (7) years I've been on CM under indefinite disciplinary confinement sanctions consisting of no telephone or visitation privileges, or canteen/Commissary, radio, tablet, or any privileges and in my case no humane treatment. Officers have repeatedly beaten me in Full restraints on video camera and off video camera with walkie-talkies fist knots ~~on~~ handcuffs and shackles utilized as weapons, ran illegal Cell Extractions on me as a guise to criminally and brutally assault me by defrauding the Use of Force CamCorder which is a regular scheme utilized to beat injure or kill inmates on CM. Officials will thwart and obstruct the view of the Video Camera and Defraud it by saying "the inmate is refusing to comply with handcuffing procedures and submit to restraints" Then force the extraction team (consisting of (5) white officers wearing riot gear) to run into the cell with the sole intent of violence.

The all white administration then simply falsify documents to conceal and cover up the evil acts, then the Inspector General's Office likewise covers it up and botches any fair investigation or evidence to prevent any disciplinary or criminal actions from being taken against these evils.

I've also been deprived of many meals, spitefully placed on strip, had all my personal property, mail, legal documents trashed, destroyed repeatedly, and repeatedly gassed with chemical agents even while in handcuffs. These injustices only skim the surface of all the atrocities I've suffered under aforementioned conspiracy to deprive me of Redress of Grievances and it would be far too time consuming and traumatizing for me "and" the reader to recap.

These circumstances have caused me extreme paranoia, trauma, nerve damage hallucinating (seeing things other people can't see) hearing things others don't hear, Bi-polar actions, delusions, resentment, hopelessness

Extreme depression, delusions, emotional distress, and suicidal ideations.

These mental illnesses require me being provided Mental Health Services in the Florida Department of Corrections designed for allowing inmates to progress off C.M. status into the General Population through Mental Health Treatment rather than being punished and attacked such as I've been to spitefully sabotage me mentally and emotionally.

Despite all the lies that have been falsified against me I've never been afforded a fair and equal opportunity of receiving mental health treatment.

Records will indicate I was transferred to Santa Rosa C.I. for Mental Health T.C.U. (Transitional Care Unit) October 2019 and was attacked by Q-Dormitory officers and reported sexual and physical abuse. As a result I was Dis-charged in Retaliation in less than (2) weeks of my admission despite having just signed my Individual Service Plan (I.S.P.) which stipulated that my mental illnesses required several weeks to begin mental health progress. Records will show this Dis-charge came immediately following me filing Complaints.

In less than (90) days I was again referred for T.C.U. mental health services and transferred to Santa Rosa C.I. Why was or would Central office of D.O.C. send me right back into Q-Dorm at the same Institution I'd been Retaliatively Dis-charged from in less than (2) weeks of my Admission after reporting sexual abuse and misconduct? (2) In less than (90) days prior? (3) With the same specific ~~officers~~ officers ~~assigned~~ assigned to this building? Because Fla. D.O.C. has no concern for fairly providing mental health treatment and did this ~~to me again~~ out of spite.

I was Again Dis-charged a 2nd time, all in less than (2) weeks of my 2nd admission and again immediately after I filed Complaints against these same officials who'd previously attacked me and were now seeking revenge against me for having filed

complaints. I was again spitefully discharged ~~because~~ (after I'd just signed mental health I.S.P. which is all evidence of the evils operating against me, but being Black I should never expect any humane treatment, by making complaints.

To do so, has caused me to be labeled as "Problematic" which in covert racism translates to "A nigger that needs to be broken until realization that he's inferior to the white mans world."

A "problematic" label means to be targeted for oppressive sabotage at institutions where Central Office of Secretary Knows are conducting Racist Occult operations such as Florida State Prison, Union C.I., Suwannee C.I. and Santa Rosa C.I. all in North Florida panhandle where Floridians are most racist and why I've never been transferred to CM camps down south beyond this region despite being circulated at these camps in a cycle of "negative transfers."

Also why only white nurses work Q-Dorm Mental Health Unit at Santa Rosa C.I. and only white officers ~~do an administration~~ (designate ~~hours~~) ~~shift~~ and ~~evenings~~ which is why the Corruption rate is so high rated in this Unit despite all these officials covering dirt for each other with the All white Administration at this Institution.

Racism is a wicked evil that obviously some sick thrill is enjoyed from it. My mental health is daily degressing from illnesses I'm suffering from all the sabotage I've disclosed in this report which I grieve daily, seeking fair and equal opportunity to ~~participate~~ attend mental health treatment programs for progressing off CM as other inmates who have far worse history of violence than what's been alleged against me without being Relatively discharged from deliberate placement in hostile corrupted environments as cited above. I file medical grievances daily reporting these illnesses I'm suffering from as aforementioned and how my depression has

been causing me to feel suicidal and how none of the Medical Mental Health Staff or officers comply with Mental Health Service Policy regarding inmates declaring "Psychological Emergencies" by ignoring or telling me to "Kill myself."

Despite me feeling or having thoughts of self harm or suicide I'm seeking treatment to cure ~~the~~ mental and emotional diseases. The only difference between me and dysfunctional inmates is that I've been suffering the mental emotional and physical attacks of hateful thrill seekers I can express what I'm experiencing but I also realize I am dysfunctional in many other aspects. But the racial bias ties in Central office of Secretary and this Institution have illegally eliminated my ^{CIVIL} rights to mental health treatment just as to filing a complaint to the extent that any unbiased treatment regiment expectations are futile at this Institution.

D.O.C. officials know I need inpatient mental health treatment program for mental and emotional stability to progress from the illegal confinement on CM where I've been for past (7) years with no privileges of speaking with or seeing my family or anything other than punishments rather than humane mental treatment.

So I'm calling on Every Citizen with a ~~normal~~ sense of morals, humanness, or justice to call in Complaints Petition Advocate and get Civil Rights ^{Legal} Actions initiated or donate funds for me to initiate them for having me released from CM or placed in mental health inpatient program designed for progressing off CM.

Policy Regulators who can establish this are Secretary office of D.O.C., Governor of Florida's Office, Department of Justice, NAACP, Law Firms, Federal Judges, F.B.I., Florida Health Department.
