Now with that being mentioned, this essay is to give my audience and the rest of the "viewing" world a more auto-biographical up close & personal in depth look into my own recent prison experience which in turn as being a "prisoner/inmate, offender or whatever title ~~is~~ placed on a convicted felon currently serving time, being identified by one of these titles means that I suffer no hardship exclusively all to myself, Even though it may have taken place individually there is almost always some sort of collateral damage or success from a particular set of circumstances, Now with that being said I would like to extend an invitation to my "fellow readers" to rewind back to a time not so long ago which ultimately has left an "permanent impression" on the psyche and mind of all living things "Pandemic" (2020), A time in all of our lives that truly set the world ablaze and I don't use that term out of its proper context because the world as we know it is still burning literally here as we speak. Be that as it may if you can remember the governments response to the "Pandemic" in my opinion in which we all have our own was more related to "Economic" well-being than it was personal well-being, you know how the Bible says "where a man's heart lies there also be his treasure". Money is the motivation for most Americans even myself at times depending on the circumstances

But with that being said the Government and (Congress) in efforts along with establishing vaccination programs and things of that nature also decided to issue every U.S. citizen a "Stimulus Check" and I'm very sure it helped if not exact that it did and still is or has been very effective depending on the nature of the need at hand. Now when I say every U.S. citizen that means incarcerated folk as well. Now this initially was met by some resistance on behalf of the U.S. government but the language of the "law" clearly said every U.S. citizen and if you know anything about prisoners and how one "Jailhouse Lawyer" research and has that particular knowledge "he or she" has it can literally beat poison down wider open (legitimately) to where the "law" on the books a lot of times is literally the equivalent of a "Cold Rush" once one cowboy makes a "serendipity" type of discovery and calls the rest of the ranchers to come out to the "West Coast" in efforts to pillage the soil for all its fertile remains. There is no question that the "Dinosaur" existed and its predatory dominance was virtually unmatched but what we do know is that it lacked the ability to adapt whether it be due to "Laziness" or pure ingenuity of "man" and an ability to deceive anything or anybody including ourselves at times in order to achieve a said goal. "Whatever" or "However" you feel about it no living thing ever has to "Apologize" for its "Survival" which is a "Victory" ~~down~~!!! Now with that being said "Prisons" as you know it are separated by "two classes" of people "Predator" and "Prey" much alike the "real" world but less weapons in terms of landscape, geography and lack of firearms at least by the inmates themselves so (Self-Defense) is very limited in terms of practical use when one is in an environment saturated with gangs and corrupt officials on the apex of the political administrative ladder on down to officers themselves who are (gung-ho) about making a profit whether it be through taking advantage of staff shortages that allow for unlimited overtime hours and this is how the shakedown takes themselves together. Every inmate has a few thousand dollars of state or government money from the (D.R.S.) to spend with whatever staff looking to earn a quick buck. So now prison has literally turned into a "crackhouse". No one can be treated its almost like "Mexico" where politics is run by the "Drug Cartels" who ultimately provide

"the campaign funds to whomever is in office or who ever is looking to run" And whoever looks to clean up the "societal problem" so to speak is ultimately marked for death for while practicing or fulfilling a "moral obligation" and not placing "Profit First" is now a "pariah" and must go at all costs when "Capitalism" by philosophical nature requires one to remove all measures of a "moral compass" in efforts to only seek increase "By any means Necessary," which is so hypocritical to the "actual" practice or philosophy of rehabilitation in and of itself, Now investors in prison privatization are yet again proven to be "economic wizards" so much so to where all economies flourished from "stimulus packages" in & out of prison, Now as it pertains to my personal situation, I felt the effects first hand when a Case Manager & Counselor who initially befriended me upon their arrival at my prior institution all for the sake of seeking a mixture of both financial and romantic gain from a "vulnerable" inmate population in which for the most part are sexually & socially starved and financially dependent on either the system or a loved one on the street, Does not to get "Biblical" but as we know according to the Bible it was Eve a woman who entertained the advances of the "Devil" and a more predatory breed of offenders who saw an opportunity to dissociate these ladies from the "cloak of protection" I placed around them in terms of educating these two young ladies of the potential dangers that came from entertaining temptations of certain inmates, Make a long-story (short Continuation) is usual

a "connotation" exclusively used in terms or in regards to a woman's "sense of awareness" but as we know it is more of a "Universal Instinct" that all humans have (Butter known to) a "Gut Feeling" - now whether people listen to that gut feeling is another thing but it does exist in all of us, Before I knew it these two rogue employees were basically entangled in the web of a "drug trafficking" scheme and ultimately under duress to chase in which they were committing these crimes for before I knew it I became the target of an increased amount of jealousy, envy and vitriol from other inmates based on a very platonic relationship with both women. The main culprit who was the head of the "Drug Trafficking" scheme whom was a "cloaked homosexual" who in his past tried to make advances toward me when we were old roommates was really upset in jealousy because in efforts to use the ladies as a "beard" saw the attention I was receiving from both ladies as competition. Now to educate my fellow reader the term "Beard" is used in the "Homosexual" community or lexicon as a way a "Gay Man" masks their sexuality with the appearance of being in a relationship with a "desirable" woman. Guys hope that in efforts of being the ~~envy~~ envy of most men this will sometimes deflect the attention from their "sexual preference" which most times backfire drastically when they're outed with one of their past or present suitors in a real-life Jerry Springer type scenario off-stage. Don't ever assume that talk-show drama isn't a depiction of real-life because it often is art imitating non-fictional events. Now here is where things even became that much more dangerous for myself after these events took place, the ring leader in what now is a "prison political propaganda" war began to spread the rumor that I had tipped authorities off on said Case Manager. Instinctually after being subject to "switch rumors" and things of that nature in a stroke of "emotional" and "intellectual genius" typed a tablet message on state issued hand held electronic device given to each inmate stating that I wanted to be moved behind potential gang war on horizon behind Case Manager being fired after cell phone was found in her

office and that she was indeed involved in trafficking phones, drugs, and weapons into facility and in effort at alerting authorities of these said events you still had a remaining Counselor still employed at the institution who intercepted my tablet (C-mail) and leaked its contents to her "love interest" who was a gang member and his fellow gang members also. Upon hearing my tablet messages being "admitted verbatim" I instantly knew it was the remaining Senate Counselor who was the "source" of the leak and I began to submit frantic "C-Mails" in "what the tower" type efforts sounding the alarm on both colleagues wrongdoings & experienced (4) continued days of horrible harassment, death threats, and the most profane language that could be used toward another human being which ultimately led to (3) outside attempts (9-24-21) 11-26-21) 11-29-21) in which I'm still receiving "Mental Health" treatment for now so we speak, I ultimately was transferred (2) weeks later after exposing a "plethora" of rogue officials to investigators which I'm not going to the full "liberation" because I only want after these officials not for their intentions of "making money" but when that "conduct" intentionally places my life or fellow officers and offenders "life in danger, that literally becomes a "War" nobody can win if they are not paying out the pocket for protection and there is supposed to be something in theory called "integrity" "Good Luck" with that, I write this Essay today to reveal together how some things meant to help ultimately can "hurt" if "abused", Survival is one thing but "Bread" is another
